

RECEIVING THE SACRAMENTS

The seven Sacraments of the Church were instituted by Christ to confer grace.

Sacrament of Baptism. Call the office to register for Parent Pre-Baptismal Instruction. For adults seeking to enter the Church and be Baptized, contact our Religious Education Office.

Sacrament of Reconciliation (Confession).

Children in our religious education program and school are prepared for Confession at age seven as part of First Communion preparation.

Sacrament of the Holy Eucharist. Children in our religious education program and school are prepared for First Communion at age seven. Adults seeking First Communion should contact our Religious Education Office. To request a visitation for Holy Communion to the Sick, contact our parish office.

Sacrament of Confirmation. Young people in our parish are prepared for reception of Confirmation in the ninth grade (age 14). Adults seeking Confirmation should contact our Religious Education Office.

Sacrament of Marriage. Couples planning for Marriage are to contact a parish priest or deacon one year in advance to set the wedding date and plan for pre-Cana instruction.


Sacrament of Holy Orders. If you believe you have, or someone you know has, a vocation to the Priesthood or Diaconate, please contact one of our parish priests.

Anointing of the Sick. For the Sacrament of Anointing of the Sick, which is administered by a Priest, a person or an immediate family member must make the request. Late night requests may not be able to be answered until the next day.

LENT

The rules for fasting an abstinence for Lent are as follows:

- · Every person 14 years of age or older must abstain from meat (and items made with meat) on Ash Wednesday, Good Friday, and all the Fridays of Lent.
- · Every person between the age of 18 and 60 must fast on Ash Wednesday and Good Friday.
- · Every person 14 years of age or older must abstain from meat (and items made with meat) on all other Fridays of the year, unless he or she substitutes some other form of penance for abstinence.

Dear Parishioners,

A terrible bill has been introduced in the Delaware State Legislature — it is a bill that would effectively set into motion the granting of power to the state of Delaware to determine circumstances in which the Seal of Confession can be vitiated and violated. It is a pernicious proposal that would insert the hand of Government above the hand of God in matters that are Sacramental.

Mixed Seasoning. Further below in this column is an article on this matter that appeared on the lifesitenews.com website a few days ago. I think it sums up the circumstances and implications of this bill. I had hoped to write more about Lent in this week's Pastor's Column, but — if you would kindly pardon the mixed seasons reference — the advent during Lent of Bill HB 74, makes this no ordinary time for this Pastor's Column.

Somebody's Watching Me? There was a song in the 1980s by singer Rockwell that featured the lyrics, "I always feel like somebody's watching me and I have no privacy. I always feel like somebody's watching me — tell me is it just a dream." In this case, the loss of confessional privacy - one regulated by the whim of the state - is not only not a dream it is a nightmare. While "somebody's watching me" provides great fodder for a song lyric, no one should ever have to sing those words walking into a confessional. On the moral and ethical end of things, this bill (HB 74) seeks to violate the Seal of Confession and it imperils the allimportant and sacred priest-penitent relationship. People need to be able to bare their souls in confession without worrying that the State of Delaware is, metaphorically, listening.

86ing HB 74. On the legal end of things, this runs smack into the freedom of religion and freedom of worship that are enshrined not just in our Federal Constitution but also in our State Constitution. The Government does not maintain, oversee, direct, or regulate the discipline (the practice) of the Sacraments. That is done by the Bishop, the Holy Father, and the Congregation for Divine Worship and the Discipline of the Sacraments. Our Federal Constitution in its First Amendment reminds us that our government "shall make no law respecting an establishment of religion, or prohibiting the free exercise thereof..." Those protections are, since the late 1860s, imposed on the States by way of the 14th Amendment. Likewise, the Delaware Constitution promises, "no power shall or ought to be vested ... that shall in any case interfere with, or in any manner control the rights of conscience, in the free exercise of religious worship." Thus this bill HB 74, is not only immoral, it is prima facie unconstitutional. Thus HB 74 should be 86'd.

An Outwards Sign, Not a Government Program. As the faithful know, the Sacraments are outward signs instituted by Christ to confer grace — they are not government programs, nor grants of governmental largesse. Confession is not the Sacrament of governmental surveillance. While some might say that the State is only seeking that a specific sin(s) be revealed if confessed, this is just the camel's nose under the tent, it is the thin edge of the wedge. The State of Delaware does not have — and indeed no government anywhere should have — a role in the Sacramental life of the Church and the Faithful.

Of Caesar and God. While we render unto Caesar that which is Caesar's, and unto God that which is God's — this is the time where we have to say to the Caesars of the world: "This is where the line is drawn, not a step further." It is my hope, that by the time you read this, this bill will have been withdrawn from consideration and be banished unto the ash heap of history. Let us pray!

Who You Gonna Call? Before I yield the contents of this column over to the text of the www.lifesitenews.com article I have referred to, I would commend the faithful of our Parish who live in Delaware to contact their state Senators and Representatives and direct them to put this bad bill to a quick and decisive end. This bill should be withdrawn.

With that, here below is the article on HB 74 and the Diocese of Wilmington's response as reported LifeSite News.

The Catholic Diocese of Wilmington has condemned proposed legislation which would require priests to break the seal of the confessional in order to reveal details of child abuse or neglect.

In the statement issued March 7, the diocese outlined the Catholic Church's teaching on the seal of the confessional and its relation to the proposed bill HB 74.

The proposed bill, introduced to the Delaware General Assembly March 2 by Rep. Eric Morrison, "abrogates the privilege between priest and penitent in a sacra-

A glimpse into the alternative was given last week.

A little bit of hustle bustle was in evidence as parents began to gather into the church. I have a love-not so loving relationship with hustle-bustle. It serves to provide an anxious anticipation for the event long prepared for while my mind keeps racing asking myself, why didn't we start this earlier? While my fingers attempted to dig in behind the newly upholstered cushion of the pew where the much-needed bobby-pins were hiding, Mrs. Gambone came to my rescue with a zip-loc bag of every little notion that might be needed for such an event as this. mental confession relating to child abuse and neglect." As such, Morrison's bill would require priests to "report child abuse and neglect or to give or accept evidence in a judicial proceeding relating to child abuse or neglect."

However, the Diocese of Wilmington – under Bishop William E. Koenig – has stated that Catholic priests would not conform to the law, which would violate a "fundamental aspect" of the Church's teaching.

"The Sacrament of Confession and its seal of confession is a fundamental aspect of the Church's sacramental theology and practice," read the statement. "It is nonnegotiable."

Koenig added that "No Catholic priest or bishop would ever break the seal of confession under any circumstances." To do so would lead to the cleric incurring an "automatic excommunication," said Koenig, which could "only be pardoned by the Pope himself."

"It would be a clear violation of the First Amendment for the government to interfere in this most sacred and ancient practice of our faith," he added.

HB 74 would not meaningfully help reduce any risk to "minors and vulnerable adults," added the Diocese of Wilmington, since "priests are already mandatory reporters under Delaware's child abuse reporting law in all circumstances other than the Sacrament of Confession."

The diocesan policies require clergy to report "suspected incidents of child abuse" to the proper civil authorities, added Koenig.

With this in mind, he stated that the proposed bill would "infringe on the rights of a variety of faith communities," but would also result in "a number of unintended consequences." These, said Koenig, would include the legal requirement of something which could not practically be done, since "the overwhelming majority of sacramental confessions are anonymous and wholly impossible to meet without violating a fundamental tenet of our faith."

"The Diocese of Wilmington considers the protection of the vulnerable to be one of the most important aims of public policy," concluded Koenig. "However, this legislation would not advance that vital objective."

The diocese's statement is supported by the Church's Code of Canon Law which notes in Canon 983 §1 that:

The sacramental seal is inviolable; therefore it is absolutely forbidden for a confessor to betray in any way a penitent in words or in any manner and for any reason.

In 2019, the Vatican's Apostolic Penitentiary re-issued this teaching in a Note, stating that "[t]he inviolable secrecy of the Confession comes directly from the revealed divine law and has its roots in the very nature of the sacrament, to the point of not admitting any exception in the ecclesial sphere, nor, even less, in the civil sphere."

The accompanying presentation of the Note pointed out how the seal of the confessional was incomparable "to the professional secrecy proper to certain professional groups (doctors, pharmacists, lawyers, etc.)" a distinction which is important "in order to prevent secular laws from applying to the seal, which is inviolable, the exceptions legitimately applied to professional secrecy."

As St. Thomas Aquinas writes, since the priest is the minister of God and acts in persona Christi during the confession, he must act as God does and not violate the secret of the confessional:

The priest should conform himself to God, whose minister he is. But God does not reveal the sins which are made known to him in confession, but hides them. Neither, therefore, should the priest reveal them.

Wilmington is not the only diocese currently facing a threat to the seal of confession. The state legislatures of Washington and Vermont are also discussing bills on mandatory reporting of sexual abuse involving children.

Spokane's Bishop Thomas Daly stated last week that if the bill proposed in the state House, HB 1098, were enacted, the Catholic clergy would refuse to comply. "Priests and bishops will go to jail rather than break the seal of confession," the bishop declared. "I'm confident that the priests in [the Diocese of Spokane] and my brother bishops would do that, so sacred is that bond."

Daly warned that the bill would have a devastating impact on the diocesan clergy themselves. "I worry that that bond of trust that people have given their life for would suddenly seem to be up for renegotiation," he said.
