Dear Parishioners,

I, like most priests, receive a monthly newsletter from the Catholic League for Civil and Religious Rights. I also (evidently) have been signed up to get online news updates from them. And I get a bunch of them. Sometimes I find some Catholic League's stuff to be hyperbolic, or polemical (though none the less, always interesting). So, I read it with a critical eye, and then check out on my own, the details of what they report.

**Bully for You!** Recently, I received one of those email updates from the Catholic League, and the headline was "PA Lawmaker Bullies Elderly Woman." Now, I could not imagine what that article was about; I mean, the idea that a lawmaker would "bully" some old lady seemed coo-coo for Cocoa Puffs crazy. The email stated: "*She [the old lady] was praying, with a rosary in hand, in front of a Planned Parenthood clinic. For eight uninterrupted minutes, [Rep. Brian] Sims badgered her, telling her to go pray at home. When she asked him to stop, he*

*followed her around and threatened to make her home address public so that others could harass her."*

**Let's go to the Videotape.** I thought for sure: This is just some hyperbolic and exaggerated moment of conflict between a lawmaker and a constituent. But I was wrong. After looking into the matter from other sources, I believe that the article headline was too reserved; perhaps "intensely haranguing" or "browbeating" would have been more accurate than "bullying." State Rep. Brian Sims of Pennsylvania, not only harassed, harangued and browbeat this old lady for praying in front of a Planned Parenthood Clinic, he actually brazenly took a video of the encounter and proudly posted it. I watched the video -- and let me say, it was painful to watch. He followed this lady as she walked and prayed her rosary. He berated her. He mocked her. He said things like:

"Have you fed any children today or have you just stood out in front of a Planned Parenthood shaming people for something they have a Constitutional right to do?"

"Actually, let's keep walking down the block. We can talk about this. We can talk about your Christian faith, about how your Christian faith believes in shaming people."

"Today's protester, now she is an old white lady who is going to try to avoid showing you her face," adding that pro-life protestors, "They're racist, classist, bigots[.]"

"There's no faith that tells you-you are right and everybody else is wrong. Don't convince yourself that what you are doing isn't extremely racist."

**A Loon Again, Naturally.** Later he tried a similar tactic on some teenage girls and their mom. Representative Sims played the scare card, the race card, the faith card, the class card, the shame card, and many other cards from the deck of loony far-left fringe, where hate seems to be a sacrament and *faux* outrage seems to be a strategy. Now, there are always folks like this in the world, but the problem is that this particular anti-Christian, pro-abortion man holds state office, and holds political power. Big problem!

**Tough Talk.** This has been a really troubling time in terms of political leaders and their treatment of the abortion issue. A few months ago, Virginia Governor Ralph Northam stirred a maelstrom of controversy when, while defending a proposed law that would allow third-trimester abortion, he commented on what would happen if a child survived an attempted abortion, just before birth. His response: "*[I]f a mother is in labor, I can tell you exactly what would happen, the infant would be delivered. The infant would be kept comfortable. The infant would be resuscitated if that's what the mother and the family desired, and then a discussion would ensue between the physicians and the mother.*" So, in other words, a child effectively brought to term would be put aside, kept comfortable, and allowed to die unless the mother and the doctor agreed otherwise. Holy Hannah! Effectively killing a child who has been born – what the heck is going on here?

**More Tough Talk.** And then there was Rep. Allen Rogers of Alabama, who in the course of a debating a bill that would give further protection to the unborn, said this: "*I'm not about to be a male telling a woman what to do with her body... Some kids are unwanted, so you kill them now or you kill them later. You bring them into the world unwanted, unloved, you send them to the electric chair. So, you kill them now or kill them later.*" Short form: Because a kid may be born in less than an ideal circumstance, you kill that child because he might become a criminal later. I repeat my previous exclamation: What the heck is going on here?

**Good News.** So, over the past few weeks I received a few emails advising me that I shouldn't support Catholic Relief Services (CRS) (which, for example, is supported by the annual Rice Bowl campaign) because they support abortion and contraceptive services. I found the assertion patently beyond the pale, as these are areas from which CRS, like any Catholic or Catholic group, steer clear and oppose. But, as I am not oblivious to the ravages of secular humanism, the culture of death and the societal permissiveness on the world in which the Church functions, I decided to check the matter out myself.

I found that most of the allegations are from 2011-2013; they were raised by the *Lepanto Institute for the Restoration of All Things in Christ* and the *Population Research Institute*. CRS, in a statement, responded saying it is fully aware of the allegations, and that those allegations are false. The statement goes on to make it clear that CRS does not partake in abortion, contraceptive services, or practices contrary to the Faith. This statement was detailed and specific, and, at least in my book, it lays the matter to rest. So, I implore you all to pray for an end to abortion, and for the conversion of heart of leaders who have bought the big lie, that they might come to embrace God's truth: He, not we, is the Lord and giver of life.


**Pregunta para los niños:** ¿Cómo hacen que sea obvio el amor que sienten por sus familiares y amigos?

# **COLUMNÁ DEL PÁRROCO PADRE JAMES LENTINI 19 DE MAYO, 2019.**

Queridos feligreses,

Yo, como la mayoría de los sacerdotes, recibo un boletín mensual de la Liga Católica de Derechos Civiles y Religiosos. También (evidentemente) me he registrado para recibir actualizaciones de noticias en línea de ellos. Y me salen un montón de ellos. A veces me parece que algunas cosas de la Liga Católica son hiperbólicas o polémicas (aunque, sin embargo, siempre interesantes). Entonces, lo leo con ojo crítico y luego verifico por mi cuenta los detalles de lo que informan.

**Bully Para Ti!** Recientemente, recibí una de esas actualizaciones por correo electrónico de la Liga Católica, y el titular fue "Un Congresista de Pensilvania insulta y Acosa a una Anciana". Ahora, no podía imaginar de qué se trataba ese artículo; Quiero decir, la idea de que un congresista "intimidara" a una anciana pareciera ser una idea loca. El correo electrónico decía: "Ella [la anciana] estaba orando, con un rosario en la mano, frente a una clínica de Planned Parenthood. Durante ocho minutos ininterrumpidos, [Rep. Brian] Sims la acosó y le dijo que fuera a rezar en casa. Cuando ella le pidió que para el acoso, él siguió y amenazó con hacer pública la dirección de su casa para que otros pudieran acosarla".

**Vayamos a la Cinta de Video.** Pensé con certeza: este es solo un momento de conflicto hiperbólico y exagerado entre un legislador y un constituyente. Pero estaba equivocado. Después de analizar el asunto de otras fuentes, creo que el título del artículo era demasiado reservado; tal vez "intensamente agresivo" o "repugnante" hubiera sido más preciso que la palabra "acoso". El representante estatal Brian Sims de Pensilvania, no solo hostigó, avergonzó y maltrató a esta anciana por orar frente a una clínica de Planned Parenthood, en realidad descaradamente tomó un video del encuentro y con orgullo lo subió y lo publicó. Vi el video, y permítanme decir que fue doloroso verlo. Siguió a esta dama mientras caminaba y rezaba su rosario. Él la reprendió. Él se burló de ella. Dijo cosas como: « ¿A cuántos niños has vestido hoy? ¿A cuántos niños has puesto zapatos en sus pies hoy? ¿Ha alimentado a algún niño mientras que estaba fuera (de la clínica) de planificación familiar avergonzando a la gente por algo que tiene el derecho constitucional de hacer?».

"En realidad, sigamos caminando por la cuadra. Podemos hablar de esto. Podemos hablar sobre su fe cristiana, sobre cómo su fe cristiana cree en avergonzar a las personas ". "La manifestante de hoy, ahora es una anciana blanca que intentará evitar mostrarte su rostro", y agregó que los manifestantes pro-vida "son racistas, clasistas, intolerantes [.]"

"No hay fe que te lo diga: tienes razón y todos los demás están equivocados. No te convences de que lo que estás haciendo no es extremadamente racista ".

**Naturalmente, Un chiflado Nuevamente.** Más tarde, intentó una táctica similar con algunas adolescentes y sus madres. El representante Sims jugó la carta de miedo, la carta de carrera, la carta de fe, la carta de clase, la carta de vergüenza y muchas otras cartas de baraja de la franja de extrema izquierda de chiflados, donde el odio parece ser un sacramento y una falsa indignación, una estrategia. Ahora, siempre hay personas como este en el mundo, pero el problema es que este hombre anti-cristiano, a favor del aborto, ocupa un cargo estatal y tiene el poder político. ¡Gran problema!

**Tome un Vistazo.** Pero, no tomes mi palabra. Le sugiero que vea este video para obtener el impacto total de lo que fue dicho y lo que le hizo a esta mujer este representante. Puede ver el video en <https://youtu.be/LQRSo9ckJQo> o ir a [www. http://www.infocatolica.com](http://www.infocatolica.com) un congresista de Pensilvania haga clic en el enlace en el cuarto párrafo) - o busque en Google las palabras "video Brian" Sims congresista de Pensilvania insulta y acosa a una anciana. Palabras Duras. Este ha sido un momento realmente preocupante para los líderes políticos y su manejo del problema del aborto. Hace unos meses, el gobernador de Virginia Ralph Northam provocó una vorágine de controversia cuando, mientras defendía una propuesta de ley que permitiría el aborto en el tercer trimestre, comentó qué sucedería si un niño sobreviviera a un intento de aborto, justo antes del nacimiento. Su respuesta: "[Si] una madre está en parto para dar a luz, puedo decirle exactamente lo que sucedería, el bebé nacería. El infante se mantendría cómodo. El bebé sería resucitado si eso es lo que deseaban la madre y la familia, y luego se produciría una discusión entre los médicos y la madre". Así que, en otras palabras, un niño efectivamente llevado a término se dejaría a un lado, se mantendría cómodo y se permitiría morir a menos que la madre y el médico acuerden lo contrario. Santa Hannah! Matar efectivamente a un niño que ha nacido, ¿qué diablos está pasando aquí?

**Más Palabras Duras.** Y luego estaba el Representante Allen Rogers de Alabama, quien en el curso de un debate sobre un proyecto de ley que brindaría mayor protección a los no nacidos, dijo esto: "No voy a ser un hombre diciéndole a una mujer qué hacer con su cuerpo..." Algunos niños no son deseados, así que los matas ahora o los matas más tarde. Los traes al mundo no deseado, no amado, los envías a la silla eléctrica. Así que, los matas ahora o los matas más tarde ". Forma corta: como un niño puede nacer en menos de una circunstancia ideal, matas a ese niño porque podría convertirse en un criminal más adelante. Repito mi exclamación anterior: ¿Qué diablos está pasando aquí?

**Buenas Noticias.** Por lo tanto, durante las últimas semanas recibí algunos correos electrónicos que me informaron que no debería apoyar a Catholic Relief Services (CRS) (que, por ejemplo, recibe el apoyo de la campaña anual "Plato de

Arroz") porque apoyan los servicios de aborto y anticoncepción. Encontré la afirmación claramente más allá de la bala, ya que estas son áreas desde las cuales CRS, como cualquier grupo católico o católico, se aleja y se opone. Pero, como no ignoro los estragos del humanismo secular, la cultura de la muerte y la permisividad de la sociedad en el mundo en que funciona la Iglesia, decidí investigar el asunto por mí mismo. Encontré que la mayoría de las acusaciones son de 2011-2013; fueron criados por el Instituto Lepanto para la Restauración de Todas las Cosas en Cristo y el Instituto de Investigación de la Población. CRS, en una declaración, respondió que es plenamente consciente de las acusaciones y que esas acusaciones son falsas. La declaración deja en claro que CRS no participa en abortos, servicios anticonceptivos o prácticas contrarias a la fe. Esta declaración fue detallada y específica, y, al menos en mi libro, establece el asunto para poner a descansar.
